Through friendly discussion, Walailak University, Thailand and Yunnan Normal University, China, have agreed to implement the cooperation of undergraduate programs on the basis of the framework agreement of both sides:

1. COOPERATION PURPOSES AND OBJECTIVES

Both parties agree that they share common interests, respect and that there will be mutual benefit for closer collaboration and joint venture in training, research, seminar, and the exchange of students, staff and academic information. Both parties agree that any activities will be carried out through mutual consultation.

Promoting the language, literature, cultural and Social Science exchange between People's Republic of China and Thailand to serve the ASEAN Economic Community (AEC) and cooperating in training dynamic talents with international experience

2. GENERAL AREAS OF COOPERATION

2.1. Enrollment of Walailak students in Study Abroad program to gain Chinese language skills, experience and social-cultural knowledge as a part of their education at YNU;

2.2. Exchange of students and academic staff (especially, visiting professors) for suitable study and training program;

2.3. Exchange of scientific materials, publications and information when possible and appropriate;

2.4. Joint ventures in academic research and conferences on social science and humanities as well as study programs (such as 3+1);

2.5. Related curriculum development activities.

3. GENERAL CONDITIONS

3.1. The terms and conditions of specific program that are agreed under the Memorandum of Understanding will be discussed by both parties and agreed in writing. The detail of each activity will be set out in a detail schedule which will be appended to this Memorandum of Understanding.

3.2. This Memorandum of Understanding shall be valid from the date last signed below for period of 5 (five) years and the implementation of any agreement will commence upon its signing by both parties subject to revision or modification by mutual consent.

3.3. Either party may at any time give notices to the other university of its intention to withdraw from this Memorandum of Understanding shall terminate 90 (ninety) days after such notice has been given.

3.4. This Memorandum of Understanding is signed by both university leaders on behalf of their respective institutions on the date shown with their signatures. In witness thereof, the Parties have caused this Memorandum of Understanding to be executed by their duty authorized representatives.
