



**MEMORANDUM OF AGREEMENT
BETWEEN
FACULTY OF CULTURAL STUDIES,
UNIVERSITAS BRAWIJAYA, INDONESIA
AND
SCHOOL OF POLITICAL SCIENCE AND PUBLIC ADMINISTRATION,
WALAILAK UNIVERSITY, THAILAND**

In consideration of the wish of the Faculty of Cultural Studies of Universitas Brawijaya, Indonesia and School of Political Science and Public Administration of Walailak University, Thailand and to establish cooperation within the framework of the academic exchange with the aim of promoting mutual academic cooperation and exchange.

This agreement entered into by and between:

Faculty of Cultural Studies of Universitas Brawijaya located at Jl. Veteran, Malang 65145, East Java, Indonesia represented herein by its Dean, Hamamah, S.Pd., M.Pd., Ph.D. and shall include its lawful representatives and permitted assigns of the first party.

and

School of Political Science and Public Administration of Walailak University located at 222 Thaiburi, Thasala, Nakhon Si Thammarat, Thailand represented herein by its Dean, Professor Dr. Surasit Vajirakachorn and shall include its lawful representatives and permitted assigns of the second party.

Whereas: Parties agree to cooperate on academic programs based on equality and reciprocity;

Whereas: Pursuant to prevailing laws and regulations in their respective countries, as well as the procedures and policy of the Government of Indonesia and the Government of Thailand concerning international collaboration on academic, scientific, and research cooperation;

Therefore, in consideration of the above, the Parties have decided to enter into a Memorandum of Agreement which, from the date of its signature.

Parties agree as follows:

Article One
Objective

The objective of the collaboration between parties are to promote mutual academic cooperation and exchange between two universities.

Article Two
Areas of Collaboration

- a. The Parties will jointly develop some or all of the following activities based on their respective academic and educational needs, such as :
 1. Exchange of faculty members and students;
 2. Exchange of academic literatures and information;
 3. Collaborative research and publication;
 4. Any other activities to be decided on the basis of mutual agreement by both universities.
- b. This collaboration will be carried out by related study programs as follows :
 1. Bachelor of English Literature
 2. Bachelor of Japanese Literature
 3. Bachelor of French Language and Literature
 4. Bachelor of Chinese Literature
 5. Bachelor of English Language Education
 6. Bachelor of Japanese Language Education
 7. Bachelor of Indonesian Language and Literature Education Study Program
 8. Bachelor of Anthropology
 9. Bachelor of Fine Arts
 10. Master of Linguistics
 11. Bachelor of Political Science
 12. Bachelor of Public Administration
 13. Master of Public Administration
 14. Doctor of Philosophy (Public Administration)
 15. Institutional internship, this includes learning about managerial, curriculum or learning media.

Article Three
Methods of Cooperation

The implementation of each joint activity set out in this Memorandum of Agreement shall be separately negotiated and determined by both universities. Details of the implementation shall be set forth in a contract to be signed at the appropriate time by representative of both parties

Article Four
Financial Provision

The terms and necessary budget for each program and project will be described in separate documents, which will be prepared subsequent to this Memorandum of Agreement will be

signed by both parties prior to the initiation of a cooperative program or project. A program may include one or more projects.

**Article Five
Non-Binding Document**

- a. This Memorandum of Agreement is not intended to be legally binding document. It is meant to describe the nature and to suggest the guidelines of the cooperation between the Parties as described above.
- b. Nothing shall diminish the full autonomy of either party nor will any constraints or financial obligations be imposed by either upon the other in carrying out the Memorandum of Agreement.

**Article Six
Duration and Termination**

- a. This Memorandum of Agreement is written in English. The two universities shall keep copy of the Memorandum of Agreement. This Memorandum of Agreement becomes effective upon completion of the signatures, valid for a period of 5 years from the date of signing.
- b. This Memorandum of Agreement is subject to revision or renewal by mutual agreement.
