Walailak University, with its principal office at 222 Thaiburi, Tha Sala District, Nakhon Si Thammarat Province, represented by its Acting President, Prof. Dr. Sombat Thamrongthanyawong.

and

De La Salle University, with its principal office at 2401 Taft Avenue, 1004 Manila, Philippines, represented by its President, Br. Bernard S. Oca FSC.

recognizing the benefits to their respective organizations from the establishment of institutional links, conclude this Memorandum.

1. The purpose of this memorandum is to develop academic and educational cooperation and promote mutual understanding between the two organizations and their respective universities.
2. This memorandum is a manifestation of the parties' intention to collaborate and is not legally binding contract.
3. Both organizations agree to conduct the following collaborative activities in academic areas of mutual interest, on the basis of equality and reciprocity;
  - a) The exchange of researcher and administrative staff;
  - b) The exchange of faculty;
  - c) The exchange of students;
  - d) Joint research activities and publications;
  - e) Dual/Double degree programs;
  - f) Lectures and symposia;
  - g) Special short-term academic programs;
  - h) The exchange of publications and other materials containing academic information; and
  - i) Other areas of academic cooperation based on mutual agreement.
4. The conduct of specific instances of these activities will be authorized in writing by the representatives of the respective organizations.
5. The ownership and use of all intellectual property created through collaborative projects authorized by this Memorandum will be determined through negotiations involving representatives from both organizations.

6. DLSU's OFFICE FOR STRATEGIC COMMUNICATIONS (STRATCOM) authorizes the two institutions to use its name, logo, and/or trademark, with the consent by the INSTITUTIONS STRATCOM in relation to promotional materials that the two institutions will disseminate to the public. The promotional materials may include, but are not limited to, posters, internet website, brochures, and any other materials related to the educational and cultural cooperation between the two parties. Such materials may not be developed, distributed and used without DLSU's STRATCOMS review and clearance.
7. WU's OFFICE FOR STRATEGIC COMMUNICATIONS (STRATCOM) authorizes the two institutions to use its name, logo, and/or trademark, with the consent by the INSTITUTIONS STRATCOM in relation to promotional materials that the two institutions will disseminate to the public. The promotional materials may include, but are not limited to, posters, internet website, brochures, and any other materials related to the educational and cultural cooperation between the two parties. Such materials may not be developed, distributed and used without WU's STRATCOMS review and clearance.
8. The resolution of unforeseen disruptions to specific instances of these activities will be determined through negotiations involving representatives from both organizations.
9. This Memorandum will be valid for five (5) years from the date of signing by the representatives of the organizations. This Memorandum may be renewed only after negotiations involving representatives of the organizations.
10. This Memorandum may be altered or terminated by either organization only after prior written notice is given to both organizations.
11. The two institutions nominate its representatives for future communication by appointing liaison officers
