



**MEMORANDUM OF UNDERSTANDING
BETWEEN
WALAILAK UNIVERSITY INTERNATIONAL COLLEGE, THAILAND
AND
UNIVERSITI TEKNOLOGI MARA, MALAYSIA**

In order to enhance mutual understanding and promote cooperation in areas such as education, academics and culture, Walailak University International College located at 222, Thaiburi, Thasala, Nakhonsithammarat, 80160, Thailand (Hereinafter referred to as WUIC), and Universiti Teknologi MARA whose main office is located at Chancellery, Universiti Teknologi MARA, 40450 Shah Alam, Malaysia (Hereinafter referred to as UiTM), agreed to establish friendly and cooperative relations between the two institutions based on principles of equality and mutual benefit. Through discussions and consultations, both parties have agreed to sign this MOU.

By mutual agreement and availability of sufficient findings and subject to and the laws, rules, regulations and national policies from time to time in force in each Party's country, WUIC and UiTM wish to cooperate in the following areas:

1. Collaboration on curriculum development and/or joint degree programs
2. Exchange of both faculty members and/or staff;
3. Exchange of both graduate and/or undergraduate students;
4. Joint research activities, workshop, and conference
5. Exchange of academic publications, materials and other information;
6. Other collaborative programs in education, academics and culture.

For the purpose of implementing the co-operation in respect of any areas stated above, the parties shall enter into legally binding agreements subject to terms and conditions as mutually agreed upon by the universities.

Both parties accept that this MOU is the foundation for mutual understanding, as well as the explicit explanation and record for bilateral cooperation. This MOU does NOT constitute or create, any legally binding or enforceable obligations, express or implied under any law or regulate any financial responsibilities.

This MOU shall take effect upon the date it has been signed by both parties and will be in effect for a period of three (3) years, with the understanding that it may be extended for another period as agreed by Parties at one Party's written request for the MOU to be extended.

Any notices will be sent by a reputable courier service to the addresses stated above and deemed served when receipt is duly acknowledged






