



**MEMORANDUM OF UNDERSTANDING
BETWEEN
THE WALAILAK UNIVERSITY,
THAILAND
AND
SOUTHWEST UNIVERSITY OF POLITICAL SCIENCE AND LAW,
PEOPLE’S REPUBLIC OF CHINA**

In accordance with a desire to promote academic cooperation in areas of mutual interest for the benefit of both institutions, **Walailak University** (hereafter referred to as “**WU**”), located at 222 Thaiburi, Thasala District, Nakhon Si Thammarat, THAILAND, and **Southwest University of Political Science and Law** (hereafter referred to as “**SWUPL**”), located at No. 301, Baosheng Avenue, Yubei District, Chongqing, CHINA, agree to cooperate in regard to international programs based on the principle of reciprocity. This Memorandum of Understanding (hereafter referred to as “**MoU**”) permits the exchange of scholars, students, academic information and materials between the signatory institutions with the following provisions:

1. WU and SWUPL agree to promote the following exchange activities based on their respective academic and educational needs:
 - a. Exchange of faculty members/researchers/staff
 - b. Exchange of students between the parties in short or long term and degree or non-degree programs, and credit transfer
 - c. Joint research in fields of mutual academic interests
 - d. Joint hosting of academic conferences and seminars/workshops
 - e. Exchange of teaching materials and curricula
 - f. Set up joint degree programme
 - g. Any other activities mutually agreed upon between the parties.
2. Collaborative programs will include faculties, undergraduate and graduate levels.
3. The parties understand that this MoU cannot entail how each collaborative project will be implemented, administered, or funded. As a result, the parties agree that they can enter into separate subsidiary agreements for each project that is selected for undertaking pursuant to this MoU.
4. This MoU shall take effect upon signature by both parties and will be effective for an initial period of five years from the date it is signed by the parties. The MoU may be extended for such further period as may be agreed by both parties in writing and may be terminated by either party giving at least three months written notice to the other. The termination of the MoU does not affect the activities that have been carried out or are being carried out unless otherwise agreed upon by the parties in writing.

5. The MoU is made in Chinese and English in duplicate, with each party holding one copy. In case of any discrepancy between Chinese and English versions, the English version shall prevail.

中国西南政法大学和泰国瓦莱岚大学 合作谅解备忘录

瓦莱岚大学（以下简称 WU），位于泰国洛坤府他沙拉县泰布里 222 号，与西南政法大学（以下简称 SWUPL），位于中国重庆市渝北区宝圣大道 301 号，秉持加强学术合作、共谋双方福祉的宗旨，基于互惠原则，就国际项目合作达成共识。为此，双方特订立本谅解备忘录（以下简称 MoU），以促进两校间进行学者、学生、学术信息交流。具体条款如下：

1. WU 和 SWUPL 将根据各自的学术和教育需求，推动以下交流活动：
 - a. 教职员工/研究人员/职员的交流互访
 - b. 短期或长期、学位或非学位项目的学生交流互访，以及学分互认
 - c. 在双方共同学术兴趣领域进行联合研究
 - d. 联合举办学术会议和研讨会
 - e. 学术材料和课程的交流
 - f. 探讨设立学位项目
 - g. 任何双方共同商定的其他活动
2. 合作项目将涵盖各院系的本科生和研究生层面。
3. 本 MoU 无法详细规定每个合作项目的实施细节。因此，双方同意可为每个根据本 MoU 开展的项目签订单独的附属协议。
4. 本 MoU 自执行之日起生效，有效期为五年，并经双方书面协定可延长至更久期限。并可在任何一方至少三个月书面通知另一方后终止。除非双方另有书面约定，谅解备忘录的终止不影响已经开展或正在开展的活动。

5. 本 MoU 以中文和英文写成，一式两份，双方各执一份。中英文版本如有差异，以英文版为主。


