MEMORANDUM OF UNDERSTANDING

between

DONG THAP UNIVERSITY (DThU),

VIETNAM

and

WALAILAK UNIVERSITY (WU),

THAILAND

This Memorandum of Understanding (MOU) is made and entered into by and between Dong Thap University, Vietnam, and Walailak University, Thailand, with the aim of fostering international cooperation in education and research.

This collaboration shall be guided by the principles of equality, reciprocity, and mutual benefit, and shall be subject to mutual written consent, availability of funding, and the approval of each institution.

1. The two institutions agree to develop the following collaborative activities including but not limited to:
 - a. Exchange of faculty members, lecturers, researchers, and other academic and administrative staff;
 - b. Exchange of students;
 - c. Joint implementation of collaborative research projects;
 - d. Organization of lectures, seminars, and symposia;
 - e. Exchange of academic information and materials of mutual interest;
 - f. Promotion of other cooperative opportunities as mutually agreed upon.
2. The implementation of activities, including technical, administrative and financial implications, under this Memorandum of Understanding shall depend upon the availability of resources and financial support; and arrangements shall be settled through consultation between the two institutions.
3. This MOU shall be amended or supplemented by a written agreement signed by the representatives of both academic institutions. Amendments and/or supplements shall be appended as an annexure.
4. The two institutions shall consult as needed, at the request of either institution, for the purpose of reviewing the operation of this MOU. For conditions not covered by this MOU, or for issues that may arise during the course of this MOU, both institutions shall refrain from unilateral action and shall negotiate mutually

acceptable decisions.

5. This MOU shall be operative on the date indicated hereunder and shall remain in force for a period of five (5) years and can be amended, extended or terminated by mutual consent of both parties.

6. This MOU is non-legally binding expression of the current intentions of both academic institutions which shall not incur nor be bound by any legal obligations or expense as a result of this MOU.
